Dear BLM Planning Team,

I am writing to provide public comment on the Draft Programmatic Environmental Impact Statement for Utility-Scale Solar Energy Development (Document #DOI-BLM-HQ-3000-2023-0001-RMP-EIS). I recreate on BLM managed public lands throughout the 11 states where utility-scale solar facility development has been proposed, especially in [note the names of states where you recreate, and/or note that you hope to recreate in the remaining states in the future]. I have concrete plans to continue recreating in BLM managed public land on a regular, recurring basis in the future.

I am concerned that plans for utility-scale solar energy development as described in the Draft Solar PEIS will negatively impact OHV recreation, and all outdoor recreation. This negative impact will directly affect me, my family, my community, and the communities and economies that are situated near the range of available land for solar projects.

While all of the 5 Alternatives proposed for the Western Solar Plan exclude Special Recreation Management Areas (SRMAs) from solar energy development, there is a great deal of indirect negative impact on the quality and viability of the OHV riding experience at SRMAs if solar facilities are developed near to the borders of SRMAs.

Also, the potential for solar projects to close public access to designated OHV routes that are outside of SRMAs is a real threat to the future of OHV recreation in many popular areas of BLM managed land. The proposed plan states: *"Many BLM field offices have completed*

planning activities to designate lands for OHV use. Under these plans, areas open to application for solar energy development may be available for OHV use, and solar energy development in these areas would displace this use. Applications for solar energy facilities may include areas containing designated open OHV routes, thereby eliminating public access along those routes."

Additionally, the Draft Solar PEIS does not exclude BLM managed lands that are designated for other specific forms of outdoor recreation (other than OHV) from the lands available for solar facility development.

In closing, I urge the BLM to incorporate the following as clearly defined exclusions within all 5 Alternatives of the Draft Solar PEIS:

- Exclude <u>designated OHV routes</u> and <u>open OHV riding areas</u> from the range of available land for construction of solar projects
- Maintain the exclusion of Special Recreation Management Areas within the final draft of the Solar Plan regardless of which Alternative or combination of Alternatives is selected
- Exclude construction of solar projects near the borders of Special Recreation Management Areas
- Exclude all designated outdoor recreation areas [including: list your favorite forms of outdoor recreation other than OHV recreation here, such as dispersed camping, designated camping, etc.)] from the lands available for construction of solar projects
